

## **Exalted Ruler's Message**



Hello again brothers and sisters, I hope this finds you well in the deep freeze of January into February. These are the days when we ask ourselves, "why do we live in Michigan". The answer is for the months of June, July, August and September because they are magnificent, and May and October can have their high points as well. Not going to lie, I'm typing this from sunny Scottsdale, AZ, where its only in the 60's but it beats 12

or 13 degrees.

But I miss being at home too. I don't mind the cold as long as there is snow and sunshine. I miss my Michigan friends, my kids and my lodge. I've seen most of Michigan and actually most of the country and still believe we live in a great place. When I left the area, I really missed it and when we had kids, we made our way back here because all our friends and family were here. Port Huron was a good fit for us, the pace of life is a little slower, people are a little nicer, the schools are good and people genuinely seem to care for one another.

I like visiting here, the weather is great, but here, people drive like jerks, other than that they seem nice, but life is lived at a faster pace. That's what I like about our community and our lodge- we care for each other, we have each other's backs and we do things for others. So, thank you Port Huron Lodge 343 for keeping us grounded. For doing great things in the community, for looking out for each other and for realizing that "there is legacy in public service". That the little things we do mean a great deal, and that the values we share make a great difference.

Last month I told you we were already in the throws of budgeting and looking at 2024. After several meetings with both the executive board and with committees we are going to be raising golf rates 5% for 2024. I know this is never popular but the costs of keeping the doors open have exceeded the 5% and to stay viable it needs to be done. We really try to not raise both golf and membership the same year, but this year we also have to raise the membership dues from \$185, to \$190, as Grand Lodge has assessed another \$5/member for insurance costs. Grand Lodge has only found one company that will insure us, and they have raised rates. Our lodge has seen about a 23% raise last year and we got off easy as some lodges were raised in excess of 30%. This is because of a couple large lawsuits against local lodges mostly because of accidents involving bar overservice.

So.....like me or hate me, you're stuck with me for another year (unless I get voted out). I've decided to do a second term. We have some things going we are trying to get in place, business models, financial structures, employee/manager reviews, capital expenditures, lodge infrastructure, etc... in 2023 into 2024, and I/we feel consistency in the ER position is important to making this happen.

While I have been gone for the month of January, John Cuthbertson has been acting as ER in my absence. John is your Leading Knight, if you don't know him you should get to. John will be a great ER in 2025, he's, intelligent, thoughtful, moral, kind, and a whole bunch more adjectives that you would use to describe a great person and a great friend. The lodge will be in good hands in 2025 and 2026 with John Woolman in the wings. That being said, we are always recruiting and looking for reasonable, intelligent, moral people without agendas, and with the good of the lodge in mind to fill the officer ranks. You can contact Exalted Ruler Gary Nesbitt or Secretary Greg Hudy to volunteer yourself for an open position.

### Nominations will be closed after Wednesday, February 14th. Voting will take place Wednesday, February 28th.

#### ARTICLE VII - NOMINATION, ELECTION, AND INSTALLATION OF OFFICERS

Section 1. Nominations for offices to be filled at the annual election in Lodges shall be made in the order in which they appear in Section 2 of Article VII of the Constitution of the Order at any regular meeting of the Lodge on or after the 1st day of January if meetings are held monthly, or otherwise after the 1st day of February and prior to the date of the annual election. If no nomination for a particular office shall have been made prior to the date of such election, or if all candidates previously nominated for a particular office shall have declined or withdrawn, nominations for that office may be made on the date of election. If a Member has been nominated for more than one office, they must declare that they accept one nomination and withdraw from the other nomination before the close of the last regular meeting of the Lodge prior to the regular meeting at which the election is to be held, and if they do not do so, they must accept only the first nomination. No Member, unless nominated in accordance with this Section, shall be eligible to election at any such annual election. Only a Member in good standing shall be eligible for nomination to office in the Lodge of which they are a Member.

## LEGACY SCHOLARSHIPS FOR ELK MEMBERS CHILDREN & GRANDCHILDREN

Legacy Awards are \$4,000 scholarships available to children and grandchildren of Elks members. The 2024 application closes on February 5, 2024 at 11:59 a.m. PST.

### WHO IS ELIGIBLE:

For the 2024 contest, any child or grandchild (or step-child, step-grandchild, or legal ward) of a living Elk who joined the order on or before April 1, 2021, or a charter member of a Lodge that was instituted on or after April 1, 2021, is eligible to apply. The Elk must also be a paid-up member through March 31, 2024. Great-grandchildren are not eligible.

The applicant must be a high school senior.

The applicant must apply online only. The 2024 Legacy Awards application deadline is February 5, 2024, 11:59 a.m. Pacific Time. If the applicant's parent and grandparent are both Elk members, the applicant must apply through the parent's Elks Lodge.

We have waived the standardized test requirement for the 2024 Legacy contest. You do not need to submit ACT and/or SAT scores.

Students may apply for more than one ENF scholarship; however, they may win only one. In cases where the student wins more than one, we will award the scholarship with the greater value. Students can accept local and state scholarships, which are separate from the awards at the national level.

Legacy Awards may only be applied to accredited US American schools, colleges or universities. (Note: Applicants from Guam, Panama, Puerto Rico and the Philippines may apply Legacy Awards toward schools, colleges or universities in their respective homes.)

If you are selected as a 2024 Legacy Awards recipient, you will be required to perform three instances of service with an Elks Lodge during the four years you are receiving the scholarship.

## WHAT IS R.E.D. FRIDAY?

RED is an acronym that stands for Remember Everyone Deployed. R.E.D. Friday was created to remind people of our heroes overseas and show that we are thinking of them. People across the country wear red every Friday to serve as a reminder and spread the message of how important it is that we keep our troops in our thoughts.

How did R.E.D. Friday Get Started? - Remember those email chains you used to get asking you to forward to 10 friends – or all of your friends? There were all kinds: some claiming ridiculous things, some trying to raise awareness for campaigns or diseases, and some that were just plain silly. This is how R.E.D. Friday originated: an email chain back in 2005.

According to SNOPES.com, the original email chain read: You will soon see a lot of people wearing RED on Fridays. Here's why..... The Americans who support our troops, are the silent majority. We are not "organized" to reflect who we are, or to reflect what our opinions are. Many Americans, like yourself, would like to start a grassroots movement using the membership of the Special Operations Association, and Special Forces Associations, and all their friends, simply to recognize that Americans support our troops. We need to inform the local VFW's and American Legion, our local press, local TV, and continue carrying the message to the national levels as we start to get this going. Our idea of showing our solidarity and support for our troops is starting Friday, and continuing on each and every Friday, until this is over, that every RED – blooded American who supports our young men and women, WEAR SOMETHING RED.

Word of mouth, press, TV — let's see if we can make the United States, on any given Friday, a sea of RED much like a home football game at a university.
